Parkside Access to College Credits General Rules and Guidelines

- High school students are eligible to take PACC courses if they are juniors or seniors in good academic standing. Students must complete the application for admission process before they will be allowed to enroll in PACC courses.
- Application for Admission Requirements: UW-System Online Application, Official High School transcript, and PACC Consent Form. It is strongly recommended that the student complete the Information Release Consent Form.
- High school students must satisfy course prerequisites and eligibility requirements for some courses (placement testing may be required).
- **Grades are permanent on your college record**, they cannot be removed and will be used to calculate your cumulative GPA in college. (College classes are more advanced and accelerated than high school classes).
- Students are responsible to drop classes on time; if courses are not dropped on-time there may be charges associated with dropping as well as transcript notations.
- Students are responsible to activate and check their UW-Parkside email, all important UW-Parkside information will be sent there. Follow the directions on your Checklist received with your admission letter.
- Students are required to act as responsible and ethical members of the campus community, please refer to the Student Handbook to find out important information.
- Participation in Orientation is strongly encouraged for both students and parents/guardians.
- Tuition must be paid in full before official transcripts will be released.
- Limited scholarships are available, consult with your counselor or the PACC Office for more information.
- Students must have regular access to a computer and the internet in order to be successful in this course.
- For every one credit hour in which you enroll, you will spend approximately 2 to 3 hours outside of class studying.
- Students should contact their instructor as soon as they feel they are falling behind or need help.
